5-YEAR WARRANTY

1. Manufacturer warrants that the CANTAR IN-GROUND REMOVABLE FENCING is free from defects in workmanship and materials for a period of five (5) years.
2. This warranty extends to original purchaser of the CANTAR IN-GROUND REMOVABLE FENCING only.
3. This warranty covers netting, poles, anchors and fasteners; BUT, DOES NOT COVER INCIDENTAL OR CONSEQUENTIAL DAMAGES, METAL FINISHES OR INSTALLATION OF THE CANTAR IN-GROUND REMOVABLE FENCING UNLESS PERFORMED BY AN AUTHORIZED CANTAR REMOVABLE FENCING DEALER. INSTALLATION IS WARRANTED BY THE INSTALLER ONLY, AND ONLY TO THE EXTENT OF EXPRESS WARRANTIES PROVIDED BY THE INSTALLER.
4. In the event of a defect, malfunction, or other failure of the Product not caused by any misuse, abuse, neglect, improper maintenance or damage to the Product while in the possession of consumer, The CANTAR will remedy the failure or defect, without charge to the consumer. The remedy will consist of repair or replacement of the Product at the warrantor's option.
5. If CANTAR is unable to provide replacement or repair, a refund will apply as follows: CANTAR will refund what is unserviceable during the first year; after the first year, the Product will be refunded at a rate of 1/60 of its cost for each month remaining of the 60 months from the original purchase date.
6. If Product is reported to be unserviceable, Product must be made available to CANTAR's representative to determine its serviceability.
7. We reserve the right to inspect Product for any claim against this warranty, to determine the cause of failure or loss of serviceability.
